# ABLE Act

#### **Policy Updates**

- Work force crisis: IL General Assembly appropriated \$12.5M for grants, recruitment, and retention of direct support persons, aides, and other frontline personnel working in communitybased services and intermediate care facilities
- Federal government funding:
  Government passed increased funding for Title I Education Grants, Special
   Education, and SSA
- **ABLE Act:** Age adjustment allows people who develop their disabilities before age 46 to establish ABLE accounts (as opposed to 26 as is currently law)

#### HB3569 and SB2026

There is a collective effort underway to support investment in community based services in IL. As part of this effort, we are supporting a \$4 an hour wage increase for direct support personnel (SB2026 and HB3569). Please consider writing your legislator to share your support for these bills. Share your story from the sibling perspective.

Here's an example: I am urging you to support HB3569 and SB2026, identical bills that would appropriate a \$4/hour wage increase for DSPs who support individuals with IDD. My sister is reliant on a DSP for activities of daily living,

including bathing, grocery shopping, and completing work-related duties. As the DSP workforce crisis worsens, I'm worried my sister will lose access to the supports that are critical to her quality of life. As a working professional myself, I do not have the capacity to become my sister's

full-time direct supporter should she lose her DSP to inadequate wages. My sister, my family, and DSPs deserve better. Please support HB3569 and SB2026 to protect my sister and others like her, invest in our communities, and create sustainable jobs.

#### Important Updates

The SSI Savings Penalty Elimination Act (Federal bill <u>H.R.</u> <u>5408/S. 2767</u>) was introduced to Congress on September 12. If passed, this would allow millions of people with disabilities to earn and save money by raising asset limits. Urge your <u>senators</u> and <u>representatives</u> to cosponsor the bill.
